COTC Continuing Education and Recognition Program

The COTC is a voluntary continuing education and recognition program administered by KLC. City officials and employees can participate by attending KLC events and by submitting outside training credit from other municipal training. If you attend a KLC training, your credit is tracked automatically when you are scanned or complete a sign in sheet.

Level I -

Achievement in City Governance -30 hours of training, including an ethics course

Level II -

Excellence in City Governance - 60 hours of training, including two hours of ethics

Level III -

Master in City Governance -90 or more hours of training, including three hours of ethics



Certified Municipal Officer (CMO)

Created in 2017, the KLC Certified Municipal Officer (CMO) designation is our way of acknowledging city officials and employees who go above and beyond in their pursuit of continued education.

To obtain this prestigious designation, individuals must complete 135 total hours of training, which is 45 hours beyond the highest level of achievement in the COTC program (90 hours.)

Only certain courses throughout the year will qualify for this program and hours can only be earned at those specific events. Make sure to look for the CMO seal of approval at future KLC training events!

This prestigious designation must include two hours of open meeting and open records training and at least one hour of advanced ethics training.



HB 119 Training Incentive Program (TIP)

In 2011, the Kentucky Legislature enacted House Bill 119 which created a new section of KRS Chapter 64 to permit any city to adopt an ordinance establishing an incentive program for city officers to obtain educational training related to the duties and responsibilities of city officers and functions of city governments. KLC can provide a sample ordinance to be used to implement this program in your city.

- Ordinance should establish a base training incentive payment to be awarded for completion of a training unity during a calendar year.
- A training unit is 15 clock hours of attendance or participation in qualifying courses during a calendar year.
- The ordinance must specify what elected officials and non-elected positions are eligible for the incentive.
- The incentive payment can range from \$100 to \$500 per completed training unit.
- The city should allocate funding in its line item budget to cover the incentive payments and training expenses.
