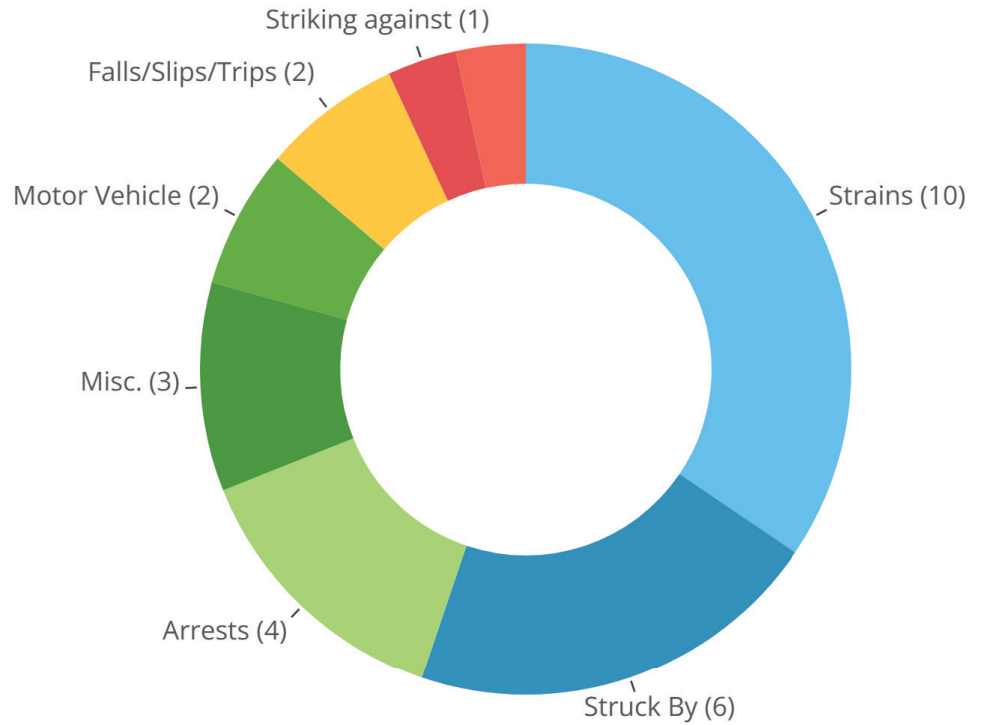
Total Claims

LAW ENFORCEMENT WORKERS' COMPENSATION CLAIMS

- 04/01/24 Item inside vehicle flew and struck top of head when he hit a bump when looking for an individual.
- 04/07/24 Blood exposure to the face when trying to serve a warrant.
- 04/09/24 Ringing in L ear and echo in both from being at shooting range for two hours.
- 04/10/24 Altercation with mental health patient; contusion/lacerations to R hand.
- 04/10/24 Foot pursuit running and fell causing swelling, bruising to R ankle.
- 04/10/24 Foot pursuit felt tightness to left knee. Tightness/throbbing pain with swelling.
- 04/12/24 Arrest altercation twisted R ankle getting into fight and twisted ankle on ground.
- 04/13/24 Injury to right shoulder while removing occupant from the vehicle during traffic stop.
- 04/14/24 Responded to calm down unruly patient with physical altercation at ER. Afterwards went home where he went into cardiac arrest and taken to local hospital and flown to UK Albert B Chandler Hospital where he passed away.
- 04/14/24 Possible bug bite to L elbow during execution of search warrant.
- 04/16/24 Pop and pain to low back while doing weighted squats.
- 04/17/24 Injured her right knee placing arrestee in vehicle.
- 04/18/24 Strained L leg pushing vehicle out of roadway.
- 04/19/24 MVA heading south struck on front driver's side of vehicle by another officer. Injury to head, and pain in neck.
- 04/19/24 Responding to call when vehicle collided with another vehicle. Injury to L hand and elbow.
- 04/19/24 Took suspect to ground, hit R hand and both knees slightly injuring them.
- 04/21/24 Needle poke to left index finger while searching lady's purse.
- 04/23/24 Performing PT Test, felt pop and pain in left hamstring.
- 04/24/24 Injured L knee after slipping on wet grass while walking K9.
- 04/24/24 In weeds checking on status of individual, noticed tick embedded in L leg below knee.
- 04/25/24 Arrest altercation trying to remove female out of vehicle and female resisted and punched in L arm.
- 04/25/24 Removing driver from car felt tightness in left arm. Prior injury to L arm.

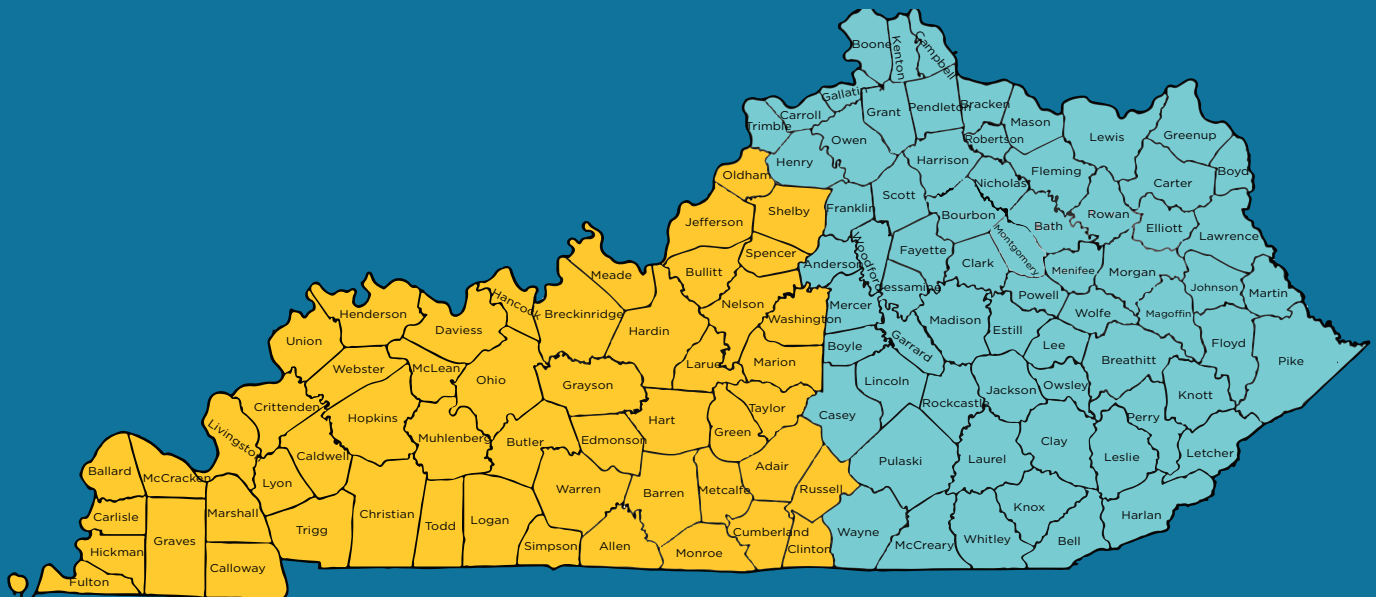
