ARE YOU CYBER SECURE?

Ransomware is finding its way into some of the most secure systems. Once established, ransomware can delete, encrypt, and even steal your organizations's data – billing, personnel, payroll, resident data, vital utility documents, and more. These pirates often hold the data hostage until you pay a ransom to get it back, and the amount demanded can be shocking. According to Harvard Business Review, ransomware attacks increased 150% in 2020, and payouts increased by more than 300% some in the tens of millions of dollars.

Steps you can take now:

- Encrypt your data
- Keep track of all equipment (laptops, tablets, and cell phones)
- Use unique passwords and update them periodically
- Use multi-factor authentication
- Establish rules for suspicious-looking emails and those with attachments
- Avoid personal activity, including email and social media, on agency equipment
- Ensure data backups are stored remotely
- Update your spam filter and malware protection software and budget for timely updates
- Train all personnel regularly about appropriate cyber hygiene practices, including tabletop exercises
- Have an incident response plan
- Utilize endpoint detection and response tools
- Use out-of-band authentication to verify wire transfer requests
